And it's a - it can create a messy situation, I guess, where each state is going to have their own set of rules based upon what the voters in that state want. Mississippi and California are going to have two different, very different perspectives on abortion. But that's the way the Constitution intended it. If it's not in the U.S. Constitution, it belongs to the people and the states, and that's what they recognized. That was, you know, it had been a long time that, that that the Roe decision was in place. But the United States Supreme Court, three years ago almost now, considered that precedent and decided it was no longer - it wasn't valid."
